Ben Ritchie, consultant from De Novo Planning Group, presented report dated May 1, 2018.

Councilmember Gibbons arrived via teleconference at 8:51 p.m.

Dennis Randall, representative from Insight Reality Company, asked Council to consider vehicle miles traveled as the traffic standard, extend transit oriented development areas, and effects of ride sharing and autonomous vehicles.

Makenzie Mossing, representative of the Santa Clara County Audubon Society, commented on letter submitted and would like nature and bird safe design included in the General Plan.

Linda Ruthruff, Conservation Chair from California Native Plant Society, commented on nature, setbacks near the creek, planting of native trees and plants.

Shani Kleinhaus, Environment Advocate for the Santa Clara Valley Audubon Society, commented on letter submitted and spoke about including bird safe design in the General Plan.

Riley Knight, Campbell resident, commented on the Los Gatos Creek trail and would like the space to be protected.

Maggie Desmond, Campbell resident, commented about retaining the small town feel and stated concerns with the maps that were used at the community meetings.

Wayne Prescott, commented on transit oriented development.

After discussion, Council provided direction to move forward and schedule a study session prior to the GPAC meeting.

Mayor Resnikoff stated they would take a five minute recess.

# 14. Civic Center Master Plan – Actions Related to a Potential Revenue Measure on the November 2018 Ballot.

Terri Lehan, former Campbell Community Librarian, commented on the library and spoke in support of a new library.

Richard Ward, Campbell resident, commented on the library and spoke in support of a new library.

Elizabeth Ward, Campbell resident, commented on the library and spoke in support of a new library.

Joan Goddard, Campbell resident, commented on problems with the library elevator and spoke in support of a new library.

Cheryl Houts, Campbell resident, commented on the library and spoke in support of a new library.

Wayne Prescott, Campbell resident, stated support for the bond over the parcel tax and commented concerns with the parcel tax.

Gayle Visher, Campbell resident, commented on the library and spoke in support of a new library.

Council discussed the issues with the hybrid parcel tax and the general obligation bond.

John Whitehurst, representative from BMWL consulting firm, commented on the general obligation bond.

Craig Hill representative from NHA advisors, provided an explanation on the payment of the general obligation bonds and the hybrid parcel tax.
